FreePoint Solar, LLC. et al. v. Town of Athens Zoning Board of Appeals. Appellate Division, Third Dept.-Case/Docket No.:CV-24-0711.
Special Counsel Dreyer Boyajian (John Dowd, Esq., Of Counsel) will be drafting and applying to the Appellate Division asking them to refer the Freepoint Solar decision to the Court of Appeals for their review and deliberation. The Town does not have a right to appeal this decision to the Court of Appeals, like Freepoint had when they appealed the Supreme Court Decision to the Appellate Division. However, the Town does have the right to make an application for an appeal to the Court of Appeals, and if it is granted, the Freepoint application will be stayed, and the Court of Appeals will hear the case. If the application is not granted, the Appellate Division decision stands and Freepoint Solar will have the ability to proceed to the Planning Board for Site Plan review.

Audit Committee. The supervisor is proposing an Audit Committee be created to assist and advise the Town Board regarding accounting, internal control, financial reporting, and relevant legal issues and enhance communication between management, the Town Board, and the external auditor. The committee will have three members, with the Supervisor serving as Chair, one Town Board member and the Bookkeeper. The term for members shall be one year.

Discussion followed and it was advised by Town Attorney McHugh, that because you will be signing documents the members of the Town board should understand what they are signing and not necessarily sign on the recommendation of a committee. There was no action taken and the committee was not formed.

The Town Board members, with Town Attorney McHugh's guidance, filled out the forms that go along with the 2025 Judicial report.

The Judicial report will be finalized, and the board will sign off on it at the March 17th meeting .
